TERMS & CONDITIONS OF MEMBERSHIP

1. Ride tracks are signed. Please follow these tracks carefully and respect the Country Code. No deviations from these routes are permitted.
2. Please carry your membership card at all times when riding on the Estate. Any person found riding the course without membership will be asked to leave immediately and may be prosecuted. Please do not abuse these facilities.
3. Game Shooting takes place around the Estate from mid-September to the end of January. To avoid upset when you hear shooting or see the shooting party, please either change course or wait until the shooting party moves on and it is safe to continue. Regretfully it is impossible to advise members of the exact location of the shooting although dates can be issued on request.
4. Riders are please asked to report any accidents, damage to any jumps or other property on the Estate, to enable us to keep up our standards of health & safety and careful maintenance.
5. Although we have attempted to make the course as safe as possible, Farnley Estates cannot be held responsible for any damage or injury to riders, horses or their property. We recommend that riders inspect jumps at all times.
6. Approved Hard Hats must be worn when riding and riders are advised to ride in pairs.
7. Mobile phones must be carried for contact with the Estate Office or emergencies services if required.
8. The course is open every day. We do however reserve the right to close any parts of the course due to poor conditions.
9. Riders under the age of 16 must be accompanied by an adult.
10. Farnley Estates Staff and Stewards have the right to ask all riders for identification at any time.
11. All riders must ride only to their ability and level of fitness.
12. All horses are required to be of a level of fitness and ability to complete the course. The Estate reserve the right to refuse access to the Estate to any horse that they have concern with as to fitness or ability.
13. Horse boxes and vehicles are parked at owners own risk.
